



# Alcohol and Other Drugs Skill Set

### COURSE DESCRIPTION:

This training provides foundational knowledge to assist you to effectively assess and provide interventions to meet the needs of people with alcohol and other drug related needs.

This skill set is for staff working in alcohol, tobacco and other drugs (ATOD) services who are members of the Alcohol, Tobacco and Other Drug Association (ATODA).

The course provides specific training on the required skills for client assessment, intervention and review.
